The **MUNICIPAL GOVERNMENT OF HERMOSA**, through its Bids and Awards Committee (BAC), invites bidder/supplier to apply for eligibility and, if found eligible, to bid for the following contract:

The BAC will conduct this public bidding in accordance with R.A.9184 and its Implementing Rules and Regulations Part A.

To be eligible to bid for this contract, a bidder/supplier must meet the following major criteria: (a) prior registration with **MUNICIPAL GOVERNMENT OF HERMOSA**, (b) Filipino Citizen or 60% Filipino-owned partnership/corporation to the type and cost of this contract, (c) completion of similar contract costing at least 50% of ABC, and (d) Net Financial Contracting Capacity at least equal to ABC, or credit line commitment/cash deposit certificate for at least 10% of ABC or. The **MUNICIPAL GOVERNMENT OF HERMOSA** will use non-discretionary pass/fail criteria in the eligibility check, preliminary examination of bids, post qualification, and award.
