KNOW ALL MEN BY THESE PRESENT:

This contract made and executed by and between LOCAL GOVERNMENT UNIT OF MUNICIPALITY OF HERMOSA represented by HON. ANTONIO JOSEPH R. INTON in his capacity as MUNICIPAL MAYOR herein after called the FIRST PARTY and BUILDERS EXPONENT EMPIRE CORPORATION represented by NOEL M. VIANZON hereinafter called the SECOND PARTY, both of legal age, Filipino and residents of Hermosa, Bataan and Orani, Bataan, respectively, witnesseth.

That the SECOND PARTY agreed to deliver EQUIPMENT (one (1) unit of payloader for 904 hrs.) as rental for the Clearing of Hermosa Garbage Transfer Facility at Brgy. That failure of the SECOND PARTY to deliver of the said equipment within the time stipulated herein he shall pay liquidated damages for each day of delay at the rate of 1/10 of 1% of the total bid price which amount will be deducted from any sum due him.
