EDORA hereinafter called the SECOND PARTY, both of legal age, Filipino and residents of Hermosa, Bataan, respectively, witnesseth.

That the SECOND PARTY agreed to deliver Sports Uniform for Elementary and Secondary in the amount of Three Hundred Ninety Two Thousand Eight Hundred Pesos and 00/100 (P 392,800.00) to be paid by the FIRST PARTY upon completion of the said deliveries approved by the authorities concerned as to qualify of supplies used and workmanship of the said goods delivered.






